
Office Order


This is to notify that the Vice-Chancellor of Bangladesh Open University (BOU) is hereby extending study leave to **Mr. Uzzal Kumar**, Assistant Professor (Philosophy), School of Social Sciences, Humanities and Languages, Bangladesh Open University for a further period of 01 (one) year to undertake PhD Program at the University of Delhi, India as per decision of the 100th urgent meeting of Standing Committee for Advanced Studies, Training and Research of BOU held on 08 August 2024 on the following terms and conditions:

1. That the leave will be effective from 01 August 2024;
2. That on return, after completion of the said study, he will work in Bangladesh Open University for the same period of leave availed of, failing for which he will have to pay compensations to BOU as may be assessed by the university authority;
3. That the progress and standard of higher study should be satisfactory and he should send progress reports on expire of every 6 (six) months;
4. That his service during his study leave will be governed by BOU rules;
5. That as soon as he completes the said course, he will join the Bangladesh Open University;
6. BOU will not bear any expenses for his PhD Program in the University of Delhi, India;
